- **11. Scope of work**: The scaled Models of P17A including fighter aircrafts and helicopter on deck to be installed at Kolkata for outdoor display. Proposal should contain all the points detailed hereunder: -
- **12. Delivery Period**: Fabrication of Scaled Models of P17A in all respects would have to be completed within 60 days from the placement of order. Please note that Contract can be cancelled unilaterally by the Buyer in case services are not received within the contracted delivery period. Extension of contracted delivery period will be at the sole discretion of the Buyer, with applicability of LO clause.


- **13. Transportation:** The bidder would be responsible for transportation of models to Kolkata under their own arrangements. Any requirements of specialist vehicle/equipment viz crane, JCB to be met by bidder within the quoted amount only. No additional claim against such utility arrangement will be considered.
- **14. Quality:** The quality of the materials and paints has to be industry grade so as to give look of original scaled warship.
- **15.Warranty:** -Item installed must have to be warranted for one year from the date of final handover.
- **16. AMC:** Vendor has to submit AMC charge from second year up to fifth year with this offer.
- **17. Inspection authority: -** GRSE or their authorised representative will carry out the inspection as per the agreed quality matrix stipulated in order. Bidder may submit a sample QAP for consideration.
- **18. Non-disclosure of Contract documents**: Except with the written consent of the Buyer/Seller, other party shall not disclose the contract or any provision, specification, plan, design, pattern, sample or information thereof to any third party.
- **19. Advance Payment: -** No advance payment(s) will be made.
- **20. Payment terms:** It will be mandatory for the Seller to indicate their bank account number and other relevant payment details so the payments could be made through ECS/EFT mechanism instead of payment through cheques, wherever feasible.

The payment will be made 100% on successful installation of Scaled Models of P17A at the designated place and acceptance by the user, on production of the requisite documents.

Amount of LD, if any, will be deducted from the billing amount.

- **21. Safety security and all associated statutory obligation:** Vendor has to well aware about the relevant safety (including fire and safety) and statutory guideline to execute such structure. All local precaution pertains to working at height, use of local power to be ensured by the bidder.
- **22. Revision in scope:** The scope mentioned herein is tentative but not restrict the bidder to propose /consider the required modification that is essential to complete the project considering all the safety, design adequacy and statutory aspect
